# TRUSTEE REPORT

The Trustees have been busy keeping our Post in tiptop shape through the winter, especially with spring right around the corner. I want to thank the Department of Corrections for their assistance in providing the Community Service personnel to assist us. Utilizing these individuals is a win/win situation for all. It enables the prisoners an opportunity to get out for the day as well as being productive in our community. This of course gives our volunteers a break and keeps our cost factor down. These individuals recently

stripped the floors in the canteen/ restaurant as well as helping with snow clearing operations.

Our new camera system is up and running. This was a major project that was over seen by our Trustee's and Executive Board. We now have high definition surveillance cameras installed throughout the interior and exterior of our facility. This will not only increase our surveillance capabilities as well as limit our liability and reduce our insurance premiums.

We are still working on our Pavilion. The plans have been submitted to our in-house Engineer Frank Baer. He is presently working with the town on this project. As you may or may not recall, there are various issues that need to be addressed as a result of our Land Use Designation. It is a work in progress.

As I have mentioned in the past, keeping our Post looking sharp requires the membership to be involved. One of our next major undertakings is the replacement of the Canteen floor. This will require us to possibly shut the Canteen for a brief period while this construction project prevails. Of course this will be done as quickly as possible with as little interruption as possible. Your input is important. Feel free to come to a meeting to discuss this endeavor



#### 2014 Bylaw Amendments/Additions

**BY-LAWS** 

Preamble:

For God and Country we associate ourselves together for the following purposes:

To uphold and defend the constitution of the United States of America; to maintain law and order; to foster and perpetuate a one hundred percent

Americanism; to preserve the memories and incidents of our associations in the great wars; to inculcate an individual obligation to the Community, State and Nation; to combat the autocracy of both the classes and the masses; to make right the master of might; to promote peace and goodwill on earth; to safeguard and transmit to prosperity the principles of justice, freedom and democracy; to consecrate and sanctify our comradeship by our devotion of mutual helpfulness.

#### Article I Name

The name of this organization shall be; "GEORGE P. VANDERVEER POST NO. 129, THE AMERICAN LEGION OF TOMS RIVER, NEW JERSEY".

#### Article II Nature

Section 1

The American Legion is a civilian organization; membership therein does not affect nor increase liability for military or police service. Rank does not exist in the American Legion. No member shall be addressed by their military or naval title in any convention or meeting of the American Legion.

#### Section 2

The American Legion shall be absolutely non-political and non-sectarian, and, shall not be used for the dissemination of partisan principles or for the promotion of the candidacy of any person seeking remunerative public office or preferment. Further; no candidate for or incumbent of a remunerative public office shall hold any office in Post 129, and, the appointment to an elective remunerative public office by any person who holds office in Post 129 shall automatically vacate that position.

Article III Eligibility Section 1

Any person shall be eligible for membership in the American Legion, who was a member of the Army, Navy, Marine Corps, Coast Guard, or Air Force of the United States and assigned to active duty at some time during the following periods: April 6, 1917 to November 11, 1918; December 7, 1941 to December 31, 1946; June 25, 1950 to January 31 1955; December 22, 1961 to May 7, 1975; August 24 1982 to July 31, 1984; December 20, 1989 to January 31, 1990 August 2, 1990 to the cessation of hostilities as determined by the government of the United States; all dates inclusive, or who, being a citizen of the United States at the time of his/her entry therein, served on active duty in the armed forces of any of the Governments associated with the United States during any of said periods; provided, however, that such service shall have been terminated by honorable separation, or continued honorably after any of said periods; provided, further, that no person shall be entitled to membership who, being in such service during any of said periods, refused on conscientious, political or other grounds to subject himself/herself to military discipline or unqualified service.

#### Section 2

There shall be no form or class of membership except an active membership and dues shall be paid annually or for life.

Section 3

An applicant for membership shall present an application with their discharge, DD-214 or other adequate proof of eligibility for membership to the membership chairperson, the membership chairperson shall carefully inspect the credentials and report to the post. [[Whereupon, the application shall be read at two post meetings prior to balloting, excepting that, one of these meetings may be waived by a two-thirds vote.]] (Note:

the post is no longer permitted to ballot applicants the black ball has been black-balled)

{{New members shall present themselves for initiation if at all practicable, when scheduled}}

#### Section 4

Any member, whose for the current year have not been paid by January First of the next year, shall be classified as delinquent. Dues received before February First shall automatically reinstate said member. A member still delinquent after the Legion Birthday, March Fifteenth, shall be suspended from all privileges of membership. A member under such suspension on June Thirtieth shall forfeit membership in the American Legion. A membership so forfeited may be reinstated through application, provided dues for the year of reinstatement have been paid.

#### Section 5

The membership Chairperson shall; maintain a complete and accurate roster of each post member's name and current address. Prepare and forward all membership cards to members and to Department Headquarters at the earliest possible convenience, upon receipt of dues. All funds collected shall be remitted to the Finance Officer. It shall also be the duty of the Membership Chairperson to notify members whose dues may be in arrears on January First and attempt to collect same.

Article IV Nominating Committee

Section 1

The Executive board shall appoint, in the month of January, a nominating committee consisting of five members, said committee shall name a candidate for each elective office. The committee shall present the resultant list to the membership at the General meeting in February and shall be published in the next issue of the official post publication 'Sound-Off', and be posted in the lounge. Service on the nominating committee shall not preclude its members from running for office.

#### Section 2

Nominations may be opened from the floor up to and including the General meeting in April. At that time nominations may be opened by a simple-majority vote.

#### Section 3

Qualifications for the office of Commander shall be; two years in office as a Vice-Commander, Adjutant, Finance Officer or any combination thereof. Qualifications for Vice-Commander shall be one year in elective office and having chaired a standing committee or special committee. All other elective or appointed offices may be filled by a member with two years in good standing.

#### Article V Elections Section 1

Post officers and the Board of Trustees, delegates and alternates to the County Committee shall be elected with a plurality of the votes cast by the members present at the General meeting held in April of each year. The polls shall be open between the hours of 7:00PM and 8:00PM.

#### Section 2

The commander, prior to the election, shall appoint one Judge to supervise the election and a sufficient number of tellers to expedite tabulation of the votes. The Judge will subsequently report the results to the membership and the adjutant shall record same in the official record.

#### Section 3

Part or the entire ballot may be dispensed with, upon motion and approval, by the members present, when there is but one candidate for said office. Balloting is necessary when more than one candidate has been nominated for any office, these

names shall be listed on the ballot by random selection. Proxy voting shall not be allowed.

Article VI Elective Officers

Section 1

The elective officers of Post 129 shall consist of; Commander, Four Vice-Commanders if equal rank, Finance Officer, Chaplain, Sergeant-at-Arms, historian and a Board of Trustees consisting of nine members.

Article VII Duties of the Elective Officers
Section 1

THE COMMANDER shall be the Chief Executive Officer of the post and shall have the duty of presiding over all General and Executive Board meetings and shall retain the general powers and duties of supervision. The commander shall appoint all standing committees and have the authority to appoint special committees with the approval of the membership. The outgoing Commander shall submit to the membership at the General meeting in July a report outlining the post activities of the preceding year with recommendations for the ensuing year.

#### Section 2

THE VICE-COMMANDERS in the absence of the Commander shall be vested with the powers to assume the duties, responsibilities and the authority of the Commander or when called upon by the Commander to do so.

#### Section 3

THE FINANCE OFFICER shall take charge of and disburse all monies and financed of the post and keep an accurate record of the same, such account shall be subject to examination of any officer or member of the post. The finance officer shall render an accounting at the General Meeting of each month, of the amount on hand and of receipts and disbursements since the previous monthly meeting.

It shall also be the duty of the finance officer to deposit all monies within forty-eight hours after receipt in a depository to be designated in the name of George P. Vanderveer Post 129, The American Legion. The finance officer shall, when in funds, pay all bills and demands as ordered by the post, and the check or draft signed by the finance officer and countersigned by the commander of adjutant.

It shall be the duty of the finance officer upon assuming office to prepare, with the assistance of the executive committee, standing committee chairpersons and post accountant, a financially a balanced budget for the ensuing year. The revenues and expenditures will be estimated from past experience and the previous year's balance sheet which shall be provided by the post accountant.

#### Section 4

THE HISTORIAN shall obtain and prepare an accurate pictorial of all post and membership activities during his/her term of office. The said history, upon approval by the membership, shall become a permanent part of the post records. The historian shall take charge of and be responsible for all video, audio and any other post equipment applicable to the position.

#### Section 5

THE CHAPLAIN shall be responsible for the spiritual leadership of the post. He or she shall offer invocations or benedictions where such prayers are required. He or she shall take part in the initiation of new members, the dedication of halls monuments and the funeral services of our comrades as required in the American Legion ritual.

#### Section 6

THE SERGEANT-AT-ARMS shall take charge of the door and verify the credentials or eligibility of those arriving, and, shall deny entrance to unauthorized persons, He or she shall take charge of the post colors and handle certain physical arrangements in the hall for meetings and ceremonies. He or she shall also learn the identities of all visitors and quests and

introduce them to the commander. The sergeant-at-arm shall preserve order as may be directed by the commander.

#### Section 7

THE BOARD OF TRUSTEES shall be chaired by the immediate past commander, with the consent of the executive board. The board shall retain custody and be responsible for all post and real property, Approve for signature be the commander, financer officer and or adjutant, all deeds, mortgages and legal documents and covenants, providing, an opinion has been obtained from legal counsel whom the board shall retain yearly with approval of the membership. The board of trustees shall monitor all budgeted expenditures and notify the appropriate officer or committee chairperson when their budget is about to be exceeded; review and monitor all bids and appropriations. The board of trustees shall meet quarterly to review post and committee records and report to the executive board as soon thereafter as practicable. The board of trustees shall inventory all post property and equipment on a yearly basis and file a record of such with the adjutant, said report shall be available for inspection by the membership.

# Article VIII Appointed Officers

Section 1

The appointed officers of Post 129 shall consist of, Adjutant, Service Officer and Judge Advocate and shall be appointed by the commander yearly, with the approval of the Executive Board.

#### Article IX Duties of the Appointed Officers Section 1

THE ADJUTANT is the corporate secretary and recording officer of the post and custodian of its records and books, excepting, those specifically assigned to others. He or she shall keep accurate record of all proceedings, these minutes shall be subject to approval by the membership and be available upon request, and, he or she shall take charge of the official seal and affix same to such documents in need of attestation. In the absence of the Judge Advocate the Adjutant shall act as parliamentarian and advise the commander, or any other member, upon request, matters of parliamentary procedure. He or she shall take charge of all correspondence. Any correspondence originating at the post shall do so through the adjutant.

#### Section 2

THE SERVICE OFFICER shall act as liaison between the veterans' and their dependents and the department of Veterans' Affairs and Ocean County Veterans' Affairs office. He or she shall assist them to the best of his or her ability and shall present their cases to the Department of New Jersey Service Officer, if necessary. He or she shall present an annual report and keep a record of all cases and their disposition to the membership.

#### Section 3

THE JUDGE ADVOCATE shall be the advisor the commander and the executive board in matters concerning the regulations and laws related to the internal affairs off the post and the American Legion. He or she shall, upon request, render opinions of a legal nature of matters affecting the post, its officers or the membership. He or she shall act as liaison between the post and legal counsel retained by the board of trustees. The judge advocate shall act as parliamentarian and shall advise the commander or any other member, upon request, matters of parliamentary procedure. The judge advocates decisions may be overturned with a simple-majority vote of members present.

#### Article X Vacancies

If one or more of the elective offices of the post become vacant the membership shall nominate and elect a successor or successors who shall fill the vacancy for the unexpired term, If one or more of the appointed offices become vacant the commander shall appoint a successor or successors, with the

approval of the membership, who shall fill the vacancy for the unexpired term.

#### Article XI Absenteeism

Any officer of the post or member of the executive board, who shall be absent from three consecutive meetings without presenting a reasonable excuse shall be relieved of his or her position and duties. A successor shall be elected or appointed a herein provided.

Article XII Meetings

Section 1

The General Membership meetings of the post shall be held on the first Monday of each month and shall be called to order at 7:00PM. Twenty-one members shall constitute a quorum. If a quorum is not obtained by 7:15PM that meeting may be canceled by the commander. There shall be no general meeting held on an official federal holiday.

#### Section 2

The Executive Board meeting shall be held on the third Monday of each month and shall be called to order at 7:00PM. Nine members of the executive board shall constitute a quorum. If a quorum is not obtained by 7:15PM that meeting may be cancelled by the commander. There shall no executive board meeting held on an official federal holiday.

#### Section 3

A special meeting of the post may be called by the commander or by a majority of the executive board. Existence of a proper quorum shall be established by the commander at the start of such special meeting and shall be reflected in the minutes. Said quorum shall consist of nine members of the executive board.

Article XIII Order of Business Section 1

The order of business at the General membership and executive board meetings shall be as follows:

- A. Opening ceremonies
- B. Introduction of guests, and prospective members.
- C. Roll Call
- D. Reading of the minutes and correspondence
- E. Reports of Officers and standing and special committees.
- F. Unfinished Business
- G. New Business
- H. Sick Call and Relief
- I. Good of the American Legion
- J. Closing Ceremonies
- K. Adjournment

Article XIV The Executive Board Section 1

The administrative affairs of the post shall be conducted by the Executive, consisting of the elected and appointed officers, Board of Trustees and by virtue of their title, all Past Commanders in good standing.

### Section 2

The Executive Board shall authorize all expenditures, subject to approval of the membership. Shall take charge of and be responsible for the management of the affairs of the Post. No business or action of the board affecting a change or establishment of policy or pertaining to the sale, purchase or transfer of any property or which entails the assets of or in any way obligates the membership, excepting routine budgeted matters shall be transacted by the board without approval from said membership. No asset of the Post shall be disposed of without written notice to all members, providing the value of said action shall exceed \$1000.00. The notice of said action shall specify the proposal and set a time and date for a vote, approval shall require a two-thirds majority vote of those present for passage. Any issue nit resolved may be tabled to the nest meeting without further written notice.

#### Section 4

Executive Board meeting are open to the general membership; however, those members shall not have the privilege of a vote. Any member may bring before the board a grievance, complaint or suggestion.

#### Article XV Committees

The Commander upon taking office shall appoint the following standing committees, subject to the approval on the membership:

#### Section 2

The Commander shall retain the authority appoint any special committees which he or she may deem necessary, subject to the approval of the membership

#### Section 3

The Committee Chairperson shall have the authority to voucher out-of-pocket expenses not to exceed \$500.00. Said expenditures will be reimbursed upon presentation of an acceptable receipt to the finance officer.

Article XVI Subordinate Organizations Section 1

A Legion Auxiliary shall be recognized by the post and shall be known as the "The Legion Auxiliary, Unit 129. It shall be the purpose of the Legion Auxiliary to aid and assist the membership in furthering the causes and principles of the American Legion accordance with the preamble of the Legion Auxiliary.

#### Section 2

Sons of the American Legion shall be recognized by the post and shall be known as "Sons of the American Legion, Squadron 129". I shall be the purpose of the SAL to aid and assist the membership in furthering the causes and principles of the American Legion in accordance with the preamble of the SAL.

#### Section 3

An American Legion Riders chapter shall be recognized by the post and shall be known as "American Legion Riders, Chapter 129" It shall be the purpose of the Legion Riders to aid and assist the membership in furthering the causes and principles of the American Legion in accordance with the preamble of the Chapter.

#### Section 4

The Past Commanders Association, organized in 1956, shall be recognized by the post to assist in furthering the causes and principles of the American Legion and aid in the administration of post business, upon request.

Article XVII Discipline and Grievances

#### Section 1

This post shall be the judge of its own membership. The disciplinary procedure shall be strictly adhered to as outlined in "Article IV" of the By-Laws of the American Legion Department of New Jersey.

#### Section 2

Any member with a grievance toward another member or members of the post may present said grievance to the Executive Board for action. If the action taken by the executive board is unsatisfactory ti the grievant, an appeal may be pursued as outlined in "Article IV" on the By-Laws of the American Legion Department of New Jersey.

#### Article VIII Parliamentary Authority

The rules contained in the current edition of "Roberts Rules of Order Newly Revised" shall govern this post in all cases to which they are applicable and in which they are not inconsistent with these By-Laws and any special rules of order the post may adopt.

#### Article XIX Amendments

#### Section 1

These By-Laws may be amended at any general membership meeting of the post by two-thirds majority vote of the members present. Providing that the proposed amendment/amendments shall have been submitted in writing at a previous executive board meeting, and further, that written notice shall gave been given to all members-at-large in advance of said date.

Publication in the post official publication, Sound-Off, shall be considered sufficient notification.

#### Section 2

Any amendments to the By-Laws of the American Legion National, Department of New Jersey or the Ocean County Executive Committee, in conflict with any provisions herein, shall be regarded as automatically repelling or modifying this document to the extent of such conflict, subject to the approval of the post executive committee.

# Article XX Life Membership Section 1

The Life Membership committee shall consist on the Life Members in good standing of Post 129 and shall be chaired by the most recently appointed Life Member.

#### Section 2

Those eligible for nomination to Life Membership shall be members in good standing who have served for twenty consecutive years in the George P. Vanderveer Post 129 of the American Legion and shall have been active at least ten of those years. Said nominee shall have held various offices and chaired and worked on various committees, qualifications shall be received by the Life Membership Committee and the decision of that committee shall be final.

### Section 3

There shall be one (1) Live membership, upon eligibility, appointed each year and will be presented at the American Legion Birthday Party held in March.

# Article XXI Bar Committee Section 1

The Commander shall appoint a bar chairperson for a one (1) year term which will coincide with the commander's term of office. The commander and the bar chairperson shall appoint a committee consisting of six (6) members. All committee members shall be members in good standing. The bar chairperson and bar committee members shall serve, subject to the approval of the executive board.

#### Section 2

The bar committee shall be responsible for the daily operation and fiscal management of all bar activities. The bar

committee shall also be responsible for establishing, regulating and enforcing all bar policies, duties and rules and regulations. The bar committee shall administer all discipline, of an immediate and emergent nature, regarding bar staff, committee members and patrons. All disciplinary action taken be the bar chairperson shall be reported to the commander and executive board for final action and possible further disciplinary action.

#### Section 3

The bar committee shall be responsible for interviewing and hiring experienced bartenders, who shall be certified by qualified certification organization. The bartenders shall be compensated from the proceeds of the bar in accordance with the laws of the State of New Jersey. The bartenders shall be responsible for filing a report of tip income with the IRS. It is required that the bartenders be a members of one of the branches of Post 129, such preference shall be to veterans first. The list of bartender duties shall be presented to all bar staff members and posted in the bar office. Bartender duties may be modified by the bar committee subject to the approval of the commander. The commander shall report all changes to the executive board.

#### Section 4

The bar chairperson/committee shall adhere to and abide by the regulations for the management of said bar as required by the laws of the Alcoholic Beverage control Commission of the state of New Jersey and the municipality of Toms River Township. The bar chairperson shall keep on file and available an up to date copy of New Jersey Alcoholic Beverage Control employee form E-141-A.

#### Section 5

The bar chairperson/committee shall setup and maintain its own checking account and take charge of its own financial transactions. All checks issued by the bar committee shall have two (2) authorized signatures. The bar chairperson, and a bar committee member, the commander and finance officer shall be signatures' of the bar account. Beer, Liquor and soda expenses shall be paid on the 15<sup>th</sup> and the last day of the month. Early payment of these bills will avoid Cash-On-Delivery status with our suppliers, as provided in ABC regulations.

### Section 6

The bar chairperson, or his designee, shall submit a financial report of the past month's activities, a list of upcoming events and any changes in the bar operations, at the monthly general meeting. At the conclusion of the report, the he or she shall present a check to the post. The check shall be in the amount of the budgeted monthly amount established by the budget committee for that fiscal year. The check may exceed the budgeted amount in any given monthly. If the monthly check will be less than the budgeted amount, the bar chairperson shall notify the commander and finance officer one (1) week prior to the general meeting.

#### New Articles:

Article XXII Remunerative Offices

The paid positions need to be defined and compensation decided upon.

## Article XXIII Standing Rules

IAW Roberts Rules this will serve as the SOP manual we have been discussing. Standing Rules are not subject to the amendment procedure required for By-Laws
